At 9:05 a.m., Captain Arlo Blevins, Corrections, joined the meeting with two (2) items:

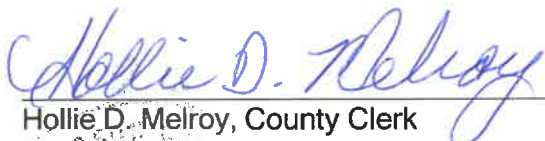
