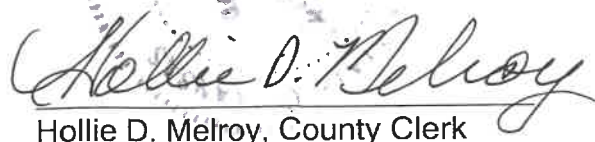
Commissioner Kueser made a motion to approve adds and abates for June 24, 2022 as presented. Commissioner O'Dell seconded. **All voted aye.**

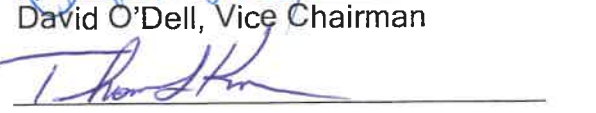
At 9:35 a.m., Commissioner Kueser made a motion to adjourn the meeting. Commissioner O'Dell seconded. **All voted aye.**
