During Public Input at 9:00 a.m., Captain Blevins introduced a recent new hire, Corrections Officer Philbrick, and presented current jail counts.

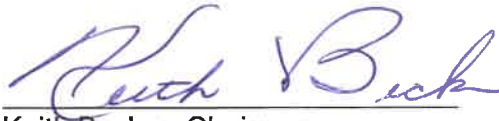

At 9:25 a.m., Julie McClure, Director of Emergency Management/Communications joined the meeting with two (2) items:

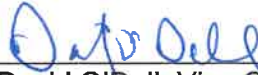

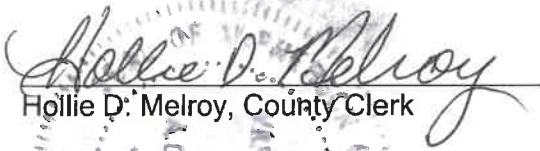
