Commissioner Kueser made a motion to approve the accounts payables, encumbrances, and reissued checks for August 21, 2023, and payroll for pay period ending August 18, 2023 as presented. Commissioner O'Dell seconded. **All voted aye.**

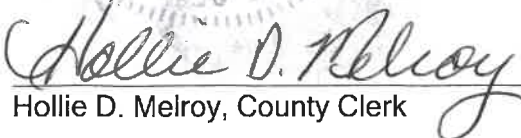
At 9:23 a.m., Commissioner Kueser made a motion to adjourn the meeting. Commissioner O'Dell seconded. **All voted aye.**
